## Incumbents re-elected to Steele-Waseca Cooperative Electric board at 80th annual meeting

With the largest attendance since 2009, four incumbent directors were re-elected to the Steele-Waseca Cooperative Electric board during the co-op's 80th annual meeting, June 7, at its headquarters in Owatonna.

Elected to three-year terms were Geraldine G. Lienke of Janesville, who ran unopposed; Dennis C. Ringhofer of Owatonna, who was challenged by Dean W. Jirousek of Ellendale; and Gary W. Wilson of Owatonna, who was challenged by Philip J. Heim of Medford. Incumbent Ronald D. Sommers of Northfield was elected to a one-year term after being appointed by the board of directors in November 2015.

Co-op display booths were available to the 824 members and guests prior to the start of the annual meeting. Steele-Waseca collected non-perishable items with donors receiving an LED bulb. The co-op wishes to thank those who donated; 253 pounds of non-perishable items and \$116.05 were collected and delivered to the Ellendale Area Food Shelf. 21539

## manager connection

Steele-Waseca Cooperative Electric had ideal weather for the co-op's 80th annual meeting which may have contributed to 824 members and guests in attendance.

Another contributing factor to the largest turnout since 2009 was the number of former Alliant Energy customers who were able to attend their first annual meeting as a member of Steele-Waseca. Southern Minnesota Energy Cooperative (SMCEC), of which Steele-Waseca is a member, purchased Alliant Energy's Minnesota service territory on July 31, 2015. So this year's annual meeting was their first opportunity to attend and experience another aspect of cooperative membership. 22504

Steele-Waseca gave members in attendance a \$30 "Power Perks" gift certificate, which enables them to utilize a credit up to \$30 at member-owned establishments.

In addition, members in attendance at the annual meeting received a \$50 Energy Star® certificate. This incentive is to encourage those members to purchase products with the Energy Star label to enhance energy efficiency at their home.

There were four districts up for election. Three of the districts were for a three-year term according to their election rotation. In District 8, incumbent Ron Sommers was re-elected to a one-year term after being appointed by the board of directors in November 2015. According to the co-op's bylaws, the board may appoint a member to serve as a director until the next annual meeting. The District 8 seat is up for its rotational election in 2017, and that will then be for the typical three-year term.

This year two of the four districts up for election had more than one candidate vying for the seat on the board. Our process of having a Nominating Committee at Steele-Waseca is a very important one. It is actually described in the co-op's bylaws, and having elections and directors that represent our member-owners is very unique in the business world and is the epitome of cooperative life.

The process actually starts in November of each year, in which the members of the Nominating Committee will meet to start the process of interviewing and eventually nominating candidates. Each year the Nominating Committee, which starts with nine members (of which three new members each year replace the three members who have served a three-year term), who call and visit

with members they personally know, or that have been recommended by other members, or have earlier in the year expressed an interest in running for the board of directors.

Sometimes we have members accept the offer and agree to run for the board, and sometimes members decide the time commitment each month is more than they can agree to. Our attorney also asks for nominations from the floor during the annual meeting for each district up for election.

If you would like to find out more information about the requirements of being a director for a future election, please contact our office or any member on the Nominating Committee, or any board member for details.

This month I also wanted to share that Steele-Waseca has joined a Community Storage Initiative, a national effort to solve the challenge of energy storage with technologies and resources that are already available.

For decades the electricity industry has been researching energy storage technologies, such as utility-scale batteries, that can stockpile electricity for later use. As the industry develops more renewable energy resources, which are intermittent, the need for energy storage is becoming more pressing.

Community storage refers to utility-sponsored programs that coordinate electric storage resources available throughout the community, such as water heaters and electric vehicles. Many utilities, including Steele-Waseca, offer consumers incentives to lower their usage during times of high demand; community storage enhances and builds on those programs.

Community storage enables consumers and utilities to share the system-wide benefits of energy storage—environmental benefits, lower costs and grid optimization—in communities large and small across the country. Such programs maximize the value of distributed energy resources, many of which are already available to participate in energy storage programs through simple retrofits and program design.

The electricity industry is undergoing a rapid transformation. By looking at resources available now and using them in a new way, we can find affordable solutions to some of our biggest challenges.

The Initiative's supporters include a wide array of energy, environmental and business interests. The Initiative members are already implementing community storage programs, and will be working together to develop and enhance those programs to fit changing energy needs.

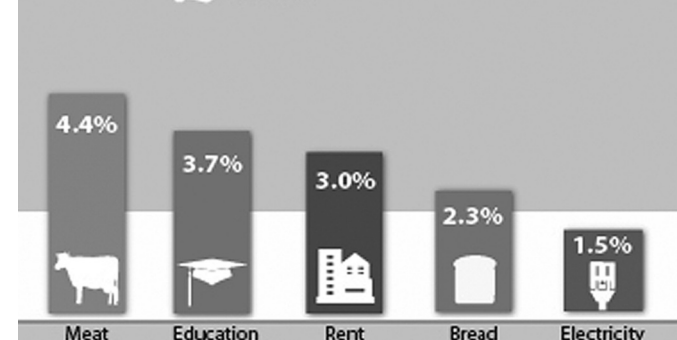

# Contact Gopher State One Call at least 48 hours before digging begins

If you are planning to complete an outdoor project that requires digging, it is important to understand and utilize Gopher State One Call (GSOC).

The GSOC system is designed to notify utilities which might have underground facilities in the area where digging is planned. That call needs to be made at least 48 hours (excluding weekends and holidays) before you plan to dig. If a homeowner hires a contractor to do the work, then by law the contractor must obtain the ticket that allows digging to proceed.

When you contact Gopher State One Call, you may call 811 or 800-252-1166. You may also visit [gopherstateonecall.org](http://gopherstateonecall.org) to submit your ticket application. Be prepared with the following information: your name, your phone number with area code first, email address, type of work you will be doing, county, city/township where work will be done; address and nearest intersecting or cross street, where you will be digging on the property (it is helpful to mark the area in white paint), whether digging will be done in the road right-of-way, and if there will be any tunnelling or horizontal boring.

Since most private facilities are not listed on GSOC, it is the homeowners responsibility to hire someone to locate their private underground facilities. A list of private locators is available at [gopherstateonecall.org](http://gopherstateonecall.org). Move your cursor

over the "About" tab on the home page and click on "Industry Directory;" then click on "Private Facility Locators." This list is by no means an exhaustive list or a list of locators recommended by GSOC. For additional locators, consult a search engine like Google or the Yellow Pages under "Utilities Underground - Locating." Remember that these locators will locate the lines for a fee. Steele-Waseca Cooperative Electric does not locate buried wires that are the homeowner's responsibility.

#### What are private electric underground facilities?

Private underground facilities are those facilities that were installed behind or after the meter. Also, if overhead distribution lines serve the property and the power is then distributed on the property by underground service facilities, those service facilities may be considered private. If the homeowner's electric meter is located on the property line, then that electric line from the meter to the house is considered privately owned and will not be located.

Steele-Waseca Cooperative Electric members wishing to join the co-op's Interruptible Central Air Conditioning Program, will receive a \$10 Dairy Queen gift card, plus a \$15 energy credit for the summer. The credit will appear in \$5 increments on your bill as an, "AIR



CONDITIONING CREDIT," in July, August and September.

This energy conservation program costs you nothing to participate and helps Steele-Waseca keep your energy bills lower.

To participate, you must have residential electric service with Steele-Waseca. The co-op will install a small radio receiver near your air conditioner's con-

natural gas farm taps, natural gas or propane gas underground piping to buildings, gas grills and pool heaters, private water systems, data communication lines, underground sprinkler systems, invisible fences and many others.

No one should ever remove flags before work is completed as they are in place to mark lines for the safety of all digging in the area. 129525

If you hit an underground utility while digging, the first thing you must do is evacuate everyone if you have created a dangerous situation. If so, call 911 immediately and keep the area clear. Also, call the utility you hit and make them aware of what has happened. Do not attempt to fix the problem yourself.



Minnesota Rural Electric Association (MREA) Safety Playbook reported an electric co-op member had attempted to locate a wire and believed they were in the clear when they attempted to drive in a post only to strike a primary wire. The fault went back to the 3-phase recloser at the substation. The fault burnt the post and grass around it. The member called 911 and fortunately wasn't injured. He was very lucky that he wasn't hurt or killed and was encouraged to have wires located before driving in any more fence posts. (Courtesy MREA Safety Playbook - Oct. 2, 2015)

densing unit at no cost to you.

During peak energy demand days, the receiver will cycle your air conditioner off and on in 15-minute intervals. Since your furnace fan continues to circulate cool air, most people rarely notice when their air conditioner is being interrupted.
