The tour includes the Coal Creek Station, Falkirk Mine with side tours of the Blue Flint Ethanol Plant and the High Voltage DC Converter Station.

The three-day tour is scheduled Tuesday, June 13, through Thursday, June 15. Travel in the comfort of a motor coach from Steele-Waseca to Bismarck, N.D., then stay at the Country Inn & Suites, which also has a water park for the kids. Each morning the hotel provides a full buffet breakfast.

During the trip to North Dakota, short educational DVDs will be played on the motor coach to give travelers a preview about what they'll see during the tours. There are fun on-the-bus games with questions and answers about information in each DVD throughout the trip for great prizes.

The tour on Wednesday, June 14, will include the Coal Creek Station to learn about the process of utilizing coal to generate electricity. Then observe the HVDC (High Voltage Direct Current) Terminal. It's here participants will see the equipment where 22,000

to 400,000 volts of direct current (DC) electricity.

From the 21st floor of Coal Creek Station, you will be able to view the Blue Flint Ethanol Plant. The plant generates over 65 million gallons of ethanol per vear by using

rather than utilizing additional boilers and burning natural gas, making Blue Flint a high efficiency ethanol plant.

Participants will also visit the Falkirk Mine to observe the open-pit mining process for lignite coal and the huge drag lines that uncover the coal. You'll learn how the land is restored to its original landscape and farmland crop production levels after the coal is mined. If weather permits, tour participants will be able to walk in the coal field and pick their own coal.

The tour price per Steele-Waseca member and their guest is \$310 per adult. One of the cooperative's goals for STUDENTS is to offer an educational opportunity about the electrical industry to our membership's young people. lars is substantial: approximately \$142 billion according to the U.S. Department of Energy based on official reports filed by investor-owned utilities. Federal studies have referred to this amount as an "interestfree loan." The annual value of this major federal assistance to investor-owned utilities is estimated at \$4.9 billion, making the subsidy to IOUs about \$47 per customer. Municipal (city-owned) electric utilities.

on average, serve 48 customers per mile of line, and issue tax-exempt bonds. The federal government loses revenue because the interest income to owners of these taxexempt bonds is not taxed. The federal subsidy to city-owned utilities in 2003 (last year available) was \$909 million or \$55 per customer. 1006128

There used to be a time when the cost of money to the government was higher than the interest received from cooperatives for loans. However, that is no longer the case. The cooperative loan program has become one of the few non-taxpaver subsidized programs in existence today. Rural electric cooperatives, on average, serve 7.4 members per mile of line (Steele-Waseca is approximately 5.2 members), and receive loans from the Rural Utilities Service (RUS). The federal assistance is the interest subsidy (federal borrowing rate minus the RUS rate) on outstanding RUS loans. According to the last available data, the cost of money to the government during 2013 was 3.45 percent. The average interest rate on RUS loans outstanding during the year was 4.13 percent. Interest paid by RUS borrowers during the year therefore exceeded the cost to the government of carrying those loans, thus the government made money on their investment in those loans.

The difference in federal subsidies for each type of utility becomes even more distinct after considering rural electric cooperatives serve sparsely populated areas across the

countryside. t Steele-



tance or subsidies in one form or another as confirmed by the Congressional Research Service. Calculations based on federal government financial reports show that rural electric cooperatives receive the least amount of subsidy per customer according to the latest available federal data.


Investor-owned electric utilities (IOUs), on average serve 34 customers per mile of line, charge electric rates that also include amounts for presumed federal tax liabilities. Prior to 1987, IOUs collected taxes based on the 46 percent corporate tax rate. But due to available tax breaks. such as investment tax credits and accelerated depreciation, IOUs were permitted to retain much of the funds they collected for federal taxes.

What does a No Barriers Warriors *expedition involve?*

No Barriers Warriors' expeditions are described as "one part adventure, one part curriculum, and one part physical challenge." Each expedition is designed to push participants mentally and physically to help them connect with fellow veterans and break through barriers in their lives. The CoBank-sponsored expedition series will take place at the No Barriers facility in the Red Feather Lakes region of Colorado. It will include activities such as mountaineering, rafting and rock climbing. Activities are specifically designed to accommodate participation by veterans with disabilities.

Why should a disabled veteran participate in this program?

Each No Barriers Warriors expedition is designed to push veterans mentally and physically in some of nature's most incredible wilderness settings. No Barriers creates a safe space for veterans to reflect on their past, recognize where they are in the present and then look with positivity to the future. They do so in a spirit of camaraderie; where veterans with a shared background come together to encourage and inspire each other. The No Barriers experience serves as both an opportunity for growth and a catalyst for change as the veterans stretch their boundaries, innovate through adversity and step up to serve others.

Why is CoBank offering this program?

What does the application process look like?

The application process includes completing an online form, interview, and medical screening. Once a nominee decides to apply, the veteran must complete the No Barriers online application. Once the application is complete, the veteran will be contacted for a phone interview conducted by a member of the No Barriers staff to ensure he or she meets eligibility requirements, understands the expedition format, and is prepared for the physical and mental challenges involved with the expedi-

The next step in the process is a medical screening conducted by a doctor trained in high altitude, back-country medicine. Once an applicant has completed these steps, they will be placed on a specific expedition team.

Yes. The Summit is open to all and, in fact, many participants bring their family with them so that they too can benefit from the experience. While the event is not specifically geared toward veterans, it does offer a special "veterans track," that will replicate much of the curriculum and experiences of the No Barriers Warriors expeditions—in a more accessible way-to accommodate veterans whose level of disability prevents them from participating in an expedition.

Can family members of veterans participate in the Summit?

Ves. Selected veterans who are unable to participate in an expedition will receive a scholarship allowing them and a caregiver/family member to attend the 2017 No Barriers Summit. Veterans who wish to include additional family members in the experience may do so at their own cost.

cookin' connection **Chicken Crescent Rolls**

3 chicken breasts	1/2 c. milk
1/2 onion (chopped)	1/2 c. chicken broth
1 1/2 sticks of oleo	1 c. grated cheddar cheese
1 can cream of chicken soup	1 can cream of mushroom soup
3 stalks celery (chopped)	2 cans crescent rolls

Boil chicken breasts and tear into small pieces. Sauté chicken, onion, celery, a stick of oleo and set aside. Mix cream of chicken soup, cream of mushroom soup, milk, 1/4 c. oleo, chicken broth and heat until combined. Then add cheddar cheese to this mixture and pour 1/3 of this mixture into a 13x9 baking dish. Using 16 crescent rolls (2 cans), separate and put chicken mixture evenly onto each and roll up. Place them on top of the sauce mixture. Pour remaining 2/3 of sauce on top of rolls and bake at 350° for 30 minutes.

health & safety connection Safety tips for home buyers

From choosing a realtor and tour-ing homes, to applying for a loan and signing many documents, buying a home can be a nerve-racking experience.

The Safe Electricity[®] program wants to help make the process a little less stressful and share tips for home buyers to help them take note of the safety of a home.

Many homes sold every year have already been lived in and have the natural wear and tear of age and use. Safe Electricity provides the following checklist to help you evaluate potential hazards:

• Outlets—note the location and the number of outlets in each room. If the outlets only have two prongs and are missing the third hole for the grounding pin, the home is not grounded. You will want to consider having the electrical system updated

• Ground fault circuit interrupters (GFCIs)-GFCIs provide protection against shock from an electrified appliance in contact with water. It is important that GFCI outlets are installed in areas where water and electricity may meet. This would include bathrooms, kitchens, garages, basements, outdoors, etc. If GFCIs are not in the home, you will want to plan on having them installed for your safety.

• Lighting-flip on lights, and listen for any popping or sizzling sounds. If there are, there may be an electrical issue

- Appliances-check the age and status of appliances that will come with the house. This could include: furnace, HVAC, water heater, refrigerator, oven, etc. Will these appliances need to be replaced in the near future? Are they working properly?
- Faucets-turn on faucets to make sure they are running and draining properly, and that there are no leaks.

• Sump pump/drainage—if the home has a basement, check for a sump



pump or proper drainage. A basement susceptible to flooding can be dangerous and costly.

Keep in mind, you likely won't be able to check every detail of the home yourself. A home inspector will examine all parts of the home, and will provide you with a full report. Anything that is wrong with the house, you can choose to negotiate with the seller to fix the issues, fix the problems yourself after purchase, or back out of the deal. If your outlets are warm, cracked or sparking, your home is sending you a message.



Don't janore the warning signs of a serious electrical problem. Shut the outlet or switch off at the circuit breaker, and contact an electrician to make repairs.



• Insulation—check to see if the home is properly insulated. Insulated areas should include attics, ducts, crawlspace walls, and floors and walls that are adjacent to unheated

• Roof—note the condition and the age of the roof, and the material it is made of. An old roof may leak and cause damage to the structure of the

• Detectors-check if smoke and carbon monoxide detectors are in

Cogeneration and Small Power Production

Steele-Waseca Cooperative Electric has available and will provide free information to all interested members regarding rates and interconnection requirements.

An application for interconnection is required for a qualifying facility to interconnect and operate in parallel with the cooperative's distribution system and is subject to approval by the cooperative. Any disputes over interconnection, sales, and purchases are subject to resolution by the Minnesota Public Utilities Commission. Members interested in further information should contact the office of Steele-Waseca Cooperative Electric.
