Steele-Waseca sponsoring 2 delegates for Youth Tour '16

Steele-Waseca Cooperative Electric is accepting applications from eligible high school sophomores or juniors for an all-expense paid trip to Washington, D.C., for the 2016 Youth Tour, June 11-16.

The tour is coordinated through the Minnesota Rural Electric Association (MREA) and hosted by the National Rural Electric Cooperative Association (NRECA). Participating cooperatives sponsor a member student(s) to travel to Washington, D.C., to learn about cooperatives and our government, tour historical sites, and have fun meeting new friends from Minnesota and other delegates from across the nation.

To be eligible, the entrant must meet the following requirements:

1. The entrant is currently a high school sophomore or junior, and his or her parent(s)/guardian(s) are a Steele-Waseca member. Dependents of Steele-Waseca employees or directors are not eligible to participate.
2. All entries must include: a) the completed application form below; b) answers to both essay questions typed on an 8.5" x 11" sheet of paper; c) applicant's school and community information typed on a separate sheet of paper; and d) two letters of recommendation (one from an instructor, counselor or administrator, and the other from a church or community leader).
3. Return entries to: Steele-Waseca Cooperative Electric, c/o Youth Tour

2016, PO Box 485, Owatonna, MN 55060. Entries must be received in Steele-Waseca's office on or before Friday, Feb. 19, 2016. The Youth Tour recipients will be notified by Friday, March 18, 2016. 17524

Each entry will be evaluated by a panel of judges for:

- completeness
- composition
- neatness
- ability to communicate
- school and community activities

Essay Questions:

1. Why would you like to be Steele-Waseca's delegate to Youth Tour 2016? What do you hope to gain from the experience? Answer in 150 words or less.

2. Write a short essay on what commitment to community means to you. Include how you contribute to your



community. Answer in 300 words or less.

School and Community Information (use a separate sheet of paper to list the following):

- All school activities – include letters and honors earned, positions held, etc.
- All community activities – include all church, community service and positions held.
- Work experience and any other information.

MREA is requiring that each participating cooperative's delegate(s) report to the Crowne Plaza Airport located at 3 Appletree Square in Bloomington for an orientation session on Saturday, June 11, at 9 a.m. An afternoon flight to Washington, D.C., will follow the orientation session. ^{5/16}

Steele-Waseca Cooperative Electric details residential rebates available in 2016

Steele-Waseca Cooperative Electric members seeking ways to maximize their energy dollar may do so through rebates offered by the co-op in 2016. The rebates for central air conditioners and air source heat pumps (ASHPs) are listed below and require a quality installation. To find a qualified installer, visit Steele-Waseca's website, swce.coop, move your cursor over "FIELD SERVICES," click on "Save Money & Energy," then click on "Qualified Installers List," in the "Quick Links" box.

14.5-14.9 SEER	\$50	\$480
15.0-15.9 SEER	\$50	\$580

Rebates for Energy Star® labeled ground source heat pumps (GSHPs) are \$400 per ton in 2016.

For members looking into electric thermal storage (ETS) heat, Steele-Waseca is offering a \$50 per kW (kilowatt) rebate up to 100 kW.

Steele-Waseca continues to offer a \$100 rebate for residential HVAC electronically commutated motors (ECMs), which offer a higher efficiency rating than typical electric blowers or condenser fan motors.

Ductless ASHPs with the Energy Star label are eligible for a \$300 rebate.

Energy Star labeled refrigerators and freezers are eligible for a \$75 rebate only if you recycle the old unit.

Dehumidifiers with the Energy Star label are eligible for a \$25 rebate.

Steele-Waseca members purchasing any Energy Star labeled appliances during the year are encouraged to call Cindy Aamot at Steele-Waseca weekdays to report their purchase. Energy Star purchases help Steele-Waseca reach their Conservation Improvement Program (CIP) goal mandated in Minnesota's 2007 Next Generation Conservation Act. The statute sets an energy conservation goal for every gas and electric utility in the state equivalent to 1.5 percent of their annual retail energy sales.

Residential lighting rebates in 2016 in-

clude the following:

- Energy Star light emitting diode (LED) lights have a \$3 per bulb rebate or up to half the cost of a multi-pack (whichever is less). LED holiday light strings have a \$2 rebate or half the package cost (whichever is less).
- Energy Star compact fluorescent lightbulbs (CFLs) have a \$1 per bulb rebate or up to half the cost of a multi-pack (whichever is less). Make sure to submit all of the numbers around the product's UPC code.

Appliance and lighting rebates may not be combined with special promotional offers through Steele-Waseca and/or its wholesale energy provider, Great River Energy.

Steele-Waseca members who install a member-owned LED security light are eligible to receive a \$30 rebate (members on the Steele-Waseca security light program are not eligible to receive a rebate); air conditioning tune-ups conducted in 2016 are eligible for a \$25 rebate; swimming pool ASHPs are eligible for a \$400 rebate; and an Energy Star variable speed pool pump is eligible for a \$200 rebate.

If you have a rebate question or wish to request a rebate form, please call Cindy Aamot at Steele-Waseca weekdays between 8 a.m. and 3:30 p.m. Rebate forms are available at Steele-Waseca's website, swce.coop, under "FIELD SERVICES," then click on "Save Money & Energy."

Completed rebate forms must be accompanied with a copy of the receipt and submitted within 90 days of purchase. Please allow six to eight weeks for processing. The rebate will appear as a credit on your monthly Steele-Waseca bill. ^{5/16}

Steele-Waseca Cooperative Electric strives to be diligent in keeping you, our member-owners, informed on safety, energy efficiency options, and events like our town hall and annual meetings. We also support programs intended for our young people living within our service area.

It's important we support our youth, not only to enrich their lives, but also instill the value of cooperative membership. After all, it's our youth who will one day become community and co-op leaders.

For high school seniors graduating in 2016, Steele-Waseca offers \$500 scholarships to those planning to continue their education on a full-time basis at a two- or four-year technical school or college.

One scholarship is awarded at each participating school. Scholarship applicants must be a dependent of a Steele-Waseca member. All eligible high school seniors should contact their guidance counselor or scholarship administrator for more information. Each participating school is responsible for administering any other eligibility requirements, and the school selects their eligible recipient.

Steele-Waseca has awarded \$141,750 since the program was established in 1954. Today, a portion of the funds to support these scholarships comes from unclaimed capital credit equity.

Two other programs sponsored by Steele-Waseca is the annual Youth Tour to Washington, D.C., and the Co-ops Yes! Youth Leadership Conference in Eau Claire, Wis.

Steele-Waseca featured the Co-ops Yes! conference in the December 2015 Sparks newsletter with details on the opportunity for sophomores, juniors, and seniors to participate.

As for the Youth Tour, eligible sophomores and juniors may send their application (details are on Page 8 of this



month's Sparks newsletter) directly to Steele-Waseca.

The tour is coordinated through the Minnesota Rural Electric Association (MREA) and hosted by the National Rural Electric Cooperative Association (NRECA).

In 2015, 41 delegates from Minnesota participated in the Youth Tour. They joined over 1,500 students from across the country who participated in their state's Youth Tour program.

While in D.C., delegates have a chance to meet with their elected officials and discuss issues that are important back home. They'll have an opportunity to learn about the cooperative business model and enjoy sightseeing in the nation's capital. 61535

The Youth Tour has grown into an invaluable program that gives young Americans an experience that will stay with them for the rest of their lives. Steele-Waseca's board of directors have been so impressed with the young men and women who have represented the co-op on the Youth Tour, that they have approved the sponsorship of two delegates starting this year to represent Steele-Waseca on the Youth Tour.

The co-op in recent years has made last year's Youth Tour delegate a part of our annual meeting. Many of you have commented on how much you enjoy hearing from our youth and the appreciation they have of their Youth Tour experience. At this year's annual meeting on Tuesday, June 7, Lucas Arndt of Owatonna (Steele-Waseca's 2015 delegate) is scheduled to highlight his Washington, D.C. Youth Tour experience. He will also introduce this year's yet-to-be-determined delegates.

Outreach with youth in the communities we serve is just one more way Steele-Waseca seeks to provide and enhance the quality of life in rural Minnesota.

ing OK. [sic]"

Morley knows of two victimized Midwest Energy business members. One lost about \$1,500; the other about \$400.

"The unfortunate thing is for each one that we know of, it's quite likely there are many others that we don't," Morley said.

Meanwhile in Colorado, Durango-based La Plata Electric Association (LPEA) is warning members about another scam in which businesses are told to pay \$500 to a "meter man" who will be there within the hour.

"Every time we turn around, there's a new twist," said Steve Gregg, LPEA chief operating officer. He said victims

are told the person is coming to install a new "GPS meter"—something that doesn't exist.

"This current scammer is claiming that they will be on-site at the location to pick up funds," said Gregg. "We definitely want to caution our members about confronting this person, or persons on your own, as you don't know who you're dealing with."

(Editor's note: Steele-Waseca Cooperative Electric was informed Dec. 21 by East Central Energy in Braham, Minn., that one of their business account members received a call and a text message from a person who claimed to represent "ECE Company." The caller threatened to shut off the electricity unless the

business made an immediate payment on their account. The business member was instructed to go to another local business, fill out an application, and then call back for further instruction. The member called the phone number that was instructed to call back, it was answered "ECE Company."

If someone calls you demanding an immediate payment or asking for banking information, immediately hang up the phone and call your local law enforcement authorities. In addition, please contact Steele-Waseca so the co-op is aware of the situation.

EPA power plant rule sets ambitious emission goals

States drafting plans to achieve 32 percent drop in carbon dioxide emissions

The Environmental Protection Agency (EPA) released its final Clean Power Plan this past summer. The rule requires states to meet emissions reduction goals for carbon dioxide (CO₂) emitted from existing fossil fuel power plants (i.e., coal and natural gas).

The Clean Power Plan is expected to achieve a 32 percent nationwide reduction in CO₂ emissions from the power sector in 2030 from 2005 levels.

How will states achieve emissions reductions?

The Clean Power Plan grants states flexibility in achieving their emissions-reduction goals. Compliance strategies can involve:

1. Improving heat rates at coal power plants
2. Substituting generation from less carbon intensive power plants (e.g., natural gas)
3. Adding low- or zero-carbon generation such as wind or solar
4. Providing incentives for consumer conservation
5. Trading credits with other sources within or outside the state

Like all utilities, Steele-Waseca Co-

operative Electric and wholesale electricity provider Great River Energy (GRE) will be affected by the rule, and are working hard to help state regulatory agencies prepare compliance plans that minimize negative impacts on members' bills or electric service.

Great River Energy's three coal power plants in North Dakota will be covered by the Clean Power Plan. The plants are among the most efficient and lowest in CO₂ emission rates in North Dakota, due in part to GRE's continued focus on improving performance. The organization is working with other utilities and officials as the state of North Dakota develops its plan to comply with the EPA's new rule.

Although GRE's power plants in Minnesota are not subject to the rule, the cooperative is also engaged in Minnesota's stakeholder process to help ensure minimal impact to rates and reliability from the state's plan.

The Clean Power Plan sets CO₂ emissions-reduction goals for each state. The rule allows states to trade under a multi-state approach, which GRE has long supported. States are required to file implementation plans to the EPA by Sept. 6, 2016. They may request a two-year extension at that time.

Rural Utilities Service loans boost co-op systems

Electric cooperatives serving 31 states, including Steele-Waseca Cooperative Electric, will share nearly \$2.3 billion in loans to build and improve systems.

"Improving our rural electric utility systems will help us continue to provide reliable and affordable electricity to rural customers," said Agriculture Secretary Tom Vilsack. "By financing these improvements, USDA helps increase efficiencies, reduce carbon emissions and improve the quality of life in rural areas."

The funding is provided through the Rural Utilities Service (RUS) Electric Loan Program.

Funding for the 77 utilities and cooperatives includes more than \$108 million for smart grid technology, \$41 million for renewable energy improvements, and \$9 million for storm damage repairs.

Steele-Waseca's loan awarded in October 2015 was for \$7.67 million for 167 miles of line improvement construction of which \$300,000 is earmarked for smart grid technology.

According to the USDA, the RUS loans in all will help build or improve 12,000 miles of transmission and distribution lines.

Steele-Waseca conducts town hall meeting for former Alliant Energy customers

Ninety two new Steele-Waseca Cooperative Electric members, formerly with Alliant Energy, were in attendance for a town hall meeting conducted Nov. 12 at the Holiday Inn Hotel & Suites in Owatonna.

Steele-Waseca General Manager Syd Briggs welcomed the co-op's newest members and explained how cooperatives operate under seven founding principles. He also detailed the association Steele-Waseca has with the National Rural Electric Cooperative Association (NRECA), Minnesota Rural Electric Association (MREA) and Cooperative Network.

Briggs outlined the development and history of SMEC (Southern Minnesota Energy Cooperative), and its role in the purchase of Alliant Energy's Minnesota service territory. He explained that un-

One phone number, multiple scams

The bad guys are becoming ever more flexible and creative in the ways they scam electric cooperative members.

"You never know who they're going to be in a given day," said Mike Morley, corporate communications manager at Midwest Energy in Hays, Kan. "They've adapted their tactics to where the same group will impersonate a number of utilities."

Morley, who first spoke to ECT.coop about scams in March 2013, said it used to be victims threatened with disconnection were told by scammers to buy a prepaid card and that they'd be called back in a couple of hours.

"Now they call and say, 'This is Midwest Energy. Your account is past due and we need you to call us back,'" Morley said, adding that spoofing software fools the caller ID into displaying "Midwest Energy."

"When they call back they get a voice menu that sounds exactly like ours. And it's not just us—other utilities in Kansas have reported this."

A Midwest Energy staffer called the toll-free number posing as a member using a phony name and account number, and was told they owed \$780. The staffer was even instructed to go to a specific nearby store to buy a ReloadIt prepaid card.

When an ECT.coop reporter dialed the same number another day, the recording claimed it was Eversource, a New England investor-owned utility. Upon reaching a live person, the reporter gave a phony location in Eversource's Springfield, Mass., territory. After tapping on a keyboard, the man on the phone told the reporter there was a \$997.78 delinquent balance and to go to a supermarket two miles away to buy ReloadIt cards and call back with the numbers.

When the reporter told the man that the address was actually in the middle of a river, the man responded, "I'm playing around with you." When asked why on another day the same number was Midwest Energy, the reply was, "Because I can do what the hell I want." Asked about how much they were making scamming people, the reporter was told, "All you need to know that we do-

DANGER! Outlet Overload

Every year, U.S. fire departments respond to an estimated **25,900 home electrical fires**. These fires cause an estimated **280 deaths, 1,125 injuries** and **\$1.1 billion in property loss**.

Thirty-nine percent of home electrical fires involve outlets and receptacles, and other electrical wiring.

To ensure safety, you should only use about 80 percent of the available current for each electrical outlet in your home.

Are you overloading outlets?
Use this formula to find out:

WATTAGE/VOLTS=AMPS

Example:

Let's say you are using 2,000 watts of power (for one outlet). Divide the watts by the volts in your home (typically 120), and you come up with 16.6 amps of current being used. With a 20 amp electrical outlet, you are using about 80 percent of the available current.

Use electric power safely

Steele-Waseca Cooperative Electric wants you to safely power your appliances and devices by not overloading outlets. Just count how many things at your residence need power. To help ensure the safety of your home and family, make sure you don't plug more than one major appliance into an outlet at a time. If an outlet isn't working, have a qualified electrician check it out, have them install more outlets on the proper circuits where needed, and replace missing or broken wall plates so wiring and components are not exposed.

der the conditions of the acquisition that closed on July 31, rates will not change for three years, any rate changes in years four and five are limited to no more than 5 percent, and SMEC is contracted to purchase power from Alliant Energy for 10 years.

Among the programs and promotions highlighted by Briggs were the Revolt electric vehicle recharging program, community solar and The Sunna Project, along with rebates available through Steele-Waseca.
