Pilot project tests "smart" Wi-Fi water heater load control device

Steele-Waseca Cooperative Electric among co-ops participating in project

Great River En-ergy (GRE) and four member-owner coop-

ENERGY eratives began a three-year pilot project in December 2020 to test a new "smart" Wi-Fi- or cellular-based water heater load control device that promises benefits to the cooperatives, member-own-

ers, and GRE. The device is manufactured by Aquanta. It offers cooperatives a hightech, low-cost technology for water heater load control programs, which allow cooperatives to turn off power to member-consumers' water heaters and reduce energy use in peak times.

Steele-Waseca's Steve Nordahl said the co-op purchased 100 devices in December and have a number installed.

"This technology is much more cost-effective than other load control devices. There are savings on both installation costs and annual operating fees," Nordahl said. "Our members also benefit. They can control the water heater themselves from an app on their smartphones and it will alert them if there is a leak."

One purpose of the pilot is to prove that load control devices connected via the internet are just as reliably connected as devices connected through the utilities' radio frequency network, which is the system that connects the cooperatives' advanced metering infrastructure.

"There is some hesitance about Wi-Fi devices, but they are well documented to have high connectivity," Nordahl said. 115750

"Members will have insight into the temperature of the water inside the water heater so we can see how 'charged' they are, like a battery. This helps us better balance our fleet of water heaters," said John Reinhart, GRE's demand response & technologies lead.

Member cooperatives need to have their own load control devices when GRE retires its old Yukon load management system in 2026.

"This fits with the vision we had when we selected our demand response management system, which offers tremendous flexibility," Reinhart said. "We knew our load control assets could take on many forms based on what members

It's why we make safety a top priority at Steele-Waseca, and devote time and energy to make everyone aware of how to stay safe around electricity.

Our line crew was called out toward the end of March for a reported vehicle collision with a Steele-Waseca power pole. The situation could have turned out deadly had the motorist attempted to leave their vehicle and touched energized lines or equipment. The adjacent graphic serves as a reminder if you ever get into a similar situation. 1016384

As the weather gets more pleasant, more outdoor projects will become a priority. If you're working with tall ladders, cleaning gutters, or undertaking other projects outside, be mindful to look up and safely stay away from overhead power lines, especially those connected to your home.

If a project involves digging, be sure to call 811 a few working days in advance to get underground utilities marked.

Help children understand the importance of staying away from electric utility equipment, to never climb trees near power lines, and to fly kites in wide open spaces, safely away from power lines.

Know how to prepare for and stay safe after storms that could leave behind hidden electrical hazards, such as downed power lines, and submerged electrical devices.

We don't want anyone to take a chance that could end in tragedy, and to help, Steele-Waseca continues their participation in the Safe Electricity program. We encourage you to visit SafeElectricity.org, or utilize the link on the co-op's website at swce.coop. The site provides life-saving information presented in videos, interactive games for children, online teacher resources, and more.

We have the safest, most reliable electric system of any country in the world, but we aren't content to rest on those laurels. We value the safety and well-being of our member-owners and Steele-Waseca employees, and we'll continue working to educate everyone on important safety

health & safety connection Practice safety when DIY-ing

These days many of us are spending I more time at home and finding new, creative ways to enhance our living space.

Tackling do-it-yourself (DIY) projects for the home can be fun and cost-effective, so why not roll up those sleeves and get started. Whether you're painting the front door with a fresh hue or finally upgrading those patio lights, successfully completing a DIY home project is incredibly satisfying. But many of these projects do not come without risks.

Here are a few safety tips to keep in mind as you get to work:

• Start by selecting a designated work area. The amount of space you'll need will depend on the size and scope of your project, but make sure you have adequate lighting and ventilation (if necessary). Required tools and equipment should be located in your workspace and organized for easy access.

• Personal protective equipment (PPE) is your friend. We know you're a pro, but investing a few bucks in PPE is essential for most home projects. Stock up on safety goggles, dust masks, ear plugs (or noise reduction ear protectors), gloves and any other kind of protection you'll need for your project. Remember to wear appropriate clothing and shoes. (Ditch the sandals for this!)

• Work slowly and clean as you go. When you rush through a DIY project, you'll likely end up with less desirable results than you intended, or worse, you could make a costly or dangerous mistake. Take your time and remember that you are in control of the project. You should also clean as you go to ensure a safer workspace. Pick up any scrap materials, tools that aren't in use and any tripping hazards.

• Be cautious with power tools. Annually, 8% of electrocutions in the U.S., are attributed to improper use of power tools. The Electrical Safety Foundation International offers the following safety tips:

1) Use ground fault circuit interrupters (GFCIs) with every power tool to protect against electrical shock.

2) Never use power tools near live electrical wires or water pipes.

3) Use extreme caution when cutting or drilling into walls where electrical wires or water pipes could be accidentally touched or penetrated.

4) If a power tool trips a safety device while in use, take the tool to a manufacturer-authorized repair center for service.

Always carry it horizontally and look up for overhead power lines before placing and climbing it.

5) Do not use power tools without the proper guards.

6) When using a wet-dry vacuum cleaner or a pressure washer, be sure to follow the manufacturer's instructions to avoid electrical shock.

Remember, you should only tackle DIY home projects within your skill and comfort level. For projects that require extensive electrical work, we strongly recommend you hire a licensed, qualified electrician for assistance.
